Operating Board Meeting Minutes

Tuesday, January 24, 2012

Diane Figg **MOVED** to nominate Scott Sistek to remain Chairman of the WCTCC operating board. Caprice Mills **SECONDED**. No discussion. **Motion carried.**

Jon Perry **MOVED** to nominate Jude Abraham as Vice Chairman Scott Sistek **SECONDED**. No discussion. **Motion carried**

Diane Heming stated that she might know someone that would be willing to attend the meetings, do the minutes, agendas, and maintain the delegate information. Jude Abraham stated that \$20 per hour would be a fair hourly rate. Caprice Mills stated that with the travel to the meetings, that in addition to the per hour rate a mileage expense set at the IRS allowable rate of .555 should be allowed. The annual amount of the hourly rate should not exceed \$750.00 as stated in the 2012 budget.


