Operating Board Meeting, Minutes

Chairman Scott Sistek called the meeting to order. Roll call was taken with the following members present: Scott Sistek, Diane Heming, Caprice Mills, Diane Figg, Paul Fry, Eileen Navish, and Greg Primm. Solicitor Lawrence Maiello was also present. <u>Election of Officers for 2016.</u> Paul Fry **MOVED** to reappoint Scott Sistek as Chairman of the WCTCC Operating Board; Diane Heming as Vice-Chairman of the WCTCC Operating Board; Caprice Mills as Secretary and Open Records Officer of the WCTCC Operating Board; and Diane Figg as Treasurer of the WCTCC Operating Board, and Eileen Navish **SECONDED.** No discussion. **Motion carried.**

<u>Approval of Minutes.</u> Diane Figg **MOVED** to approve the minutes of the Operating Board Meeting held on October 26, 2015, and Diane Heming **SECONDED**. No discussion. **Motion carried**.

Approval of Bills. Approval of bills was conducted at the full WCTCC meeting held earlier this morning.

<u>Public Comment.</u> For the record there was no public comment at the meeting.

<u>Treasurer's Report.</u> Greg Primm **MOVED** to approve the addition of Caprice Mills to the current list of check signers on the checking account (two signatures are required), and Eileen Navish **SECONDED**. No further discussion. **Motion carried**.

Solicitor's Report. Solicitor Maiello updated the Board on the claim the WCTCC had into the bonding company for CENTAX for a couple thousand dollars; the Board opted to let it ride because they were requesting a Full and Final Release. Solicitor Maiello would need authorization to issue the Full and Final Release in connection with the WCTCC being reimbursed for any claims.

Diane Figg **MOVED** to approve the authorization for Solicitor Maiello to issue the Full and Final Release to recoup any pending claims from the CENTAX bond, and Diane Heming **SECONDED.** No further discussion. **Motion carried.**

- 2. Berkheimer Fees. Solicitor Maiello asked the members to research the fee structures of any entities using Berkheimer of similar size. The current percentage is 1.42%.
