<u>APPROVAL OF MINUTES (5/25/2010):</u> For the record, the minutes could not be approved without a quorum present. This will be added to next month's agenda.

**NEXT MEETING:** Mr. Koluder, "The next meeting is scheduled for July 27, 2010 at 6:30 p.m. at the Westmoreland County Courthouse."

### **COMMITTEE UPDATES:**

Bylaws Committee-Joe Koluder, Chairperson. Mr. Koluder, "There's one update to the Bylaws and obviously we won't be able to do that this evening. Our Bylaws require a majority vote, but hopefully we'll have a majority vote at the next meeting because that's when we're intending to approve the RFP or make a recommendation to the group. Our insurance agent recommended to us that we probably should have in the Bylaws the mention of the WCTCC indemnifying all of us committee members. We do have an Errors and Omissions policy that we purchased but their recommendation was to put it inside our Bylaws."

Solicitor Falco Muscante, "What they had proposed was language for indemnification that would be consistent with a non-profit corporation. Our office kind of took that and tweaked it a little bit so it's more consistent with the Political Subdivision Tort Claims Act which more directly applies in this situation. So the language I think that was circulated to all the delegates is the language that our office had put together which tracks the language from the statute itself." Mr. Koluder, "So that is the motion that we'll add to the Bylaws whenever we get around to voting on it. It does take two-thirds of the committee to make a change to the Bylaws. I think the best time for that to happen will be at the meeting where we vote for the Tax Collector. Are there any questions on that change?"

# Solicitor Committee-No report.

Finance Committee-Joe Koluder. Mr. Koluder, "We can't approve the bills but we're down to three past-due invoices; three municipalities. I think maybe we can get some help; Arona Borough, Monessen City and Trafford Borough. If anyone knows of anyone from those three locations, ask them to contact, Mary, myself or Diane Figg. We can help them in letting them know what they owe."

Mary Perez, "We've sent letters more than once with invoices; none of those three entities has delegates or alternates named to this committee."

"Do you have copies of the invoices we can take with us to hand deliver to somebody?" Ms. Perez, "No, but if you contact Diane Figg or shoot me an e-mail if you don't have her e-mail address, then she'll be sure to get you a copy. She can e-mail it to you." Mr. Koluder, "Thank you."

Tax Collector RFP Committee-Joe Koluder. Mr. Koluder, "Dan has a Board meeting this evening so he couldn't make it, but we just had another meeting with the RFP Committee narrowing down the selection to come back with a recommendation to the full WCTCC. We know our target date is July 27, 2010. I can tell you for sure sitting here now we're going to make every attempt to make that meeting for the recommendation, but there's a possibility that it might have to go into August because we've scheduled some meetings. We have two more meetings scheduled now; one for next Tuesday, June 29<sup>th</sup> and we're also scheduling to sit down and meet with each of these three Tax Collectors that have bid on July 14<sup>th</sup>. Hopefully we can come to a consensus then and bring a recommendation back on July 27<sup>th</sup>. That's our intention and we'll let you know if we're not going to make that date, but we have to have that approved at either the July 27<sup>th</sup> meeting or the August meeting because it must be done by September 15<sup>th</sup>. So please make plans to attend the July 27<sup>th</sup> meeting because that's when we're hoping to have someone ready to recommend. If we don't, we'll let you know, but that's our goal to have a recommendation at that time."

Ms. Perez, "Did you say there's another RFP meeting scheduled on June 29<sup>th</sup>? Do you want to let them know the time and location in case they want to attend?"

Mr. Koluder, "It will be at the Greensburg Salem Middle School at the Administration building at 1:00 p.m. The next meeting on July 14<sup>th</sup> is when we're meeting with the candidates for questions and we're starting that at 1:00 p.m. as well; they're scheduled 1½ hours apart." "Will there be an e-mail as a reminder?"

Ms. Perez, "Yes, I can send that out. So you're inviting the entire WCTCC to that?" Mr. Koluder, "The members of the WCTCC are always invited but it's going to be hard for you to catch up because there have been a lot of meetings to get us to this point. But it's certainly open to the WCTCC group."

Website-Joe Koluder. Mr. Koluder, "Westmoreland County has now created a link to our website from their website. It is in two locations under Links and also under Departments; Assessments, Lands and Records in case you're interested."

**Upcoming WCTCC Meetings-Joe Koluder.** Mr. Koluder, "The next meeting is July 27, 2010 at 6:30 p.m. Our intention is to have a two-thirds majority here because we have to pass the Bylaws change as well as hopefully be ready to recommend the selection of the Tax Collector. Are there any questions from the group?"

"I just have a suggestion. You had talked about the meetings that we're going to have about the RFP that if anybody from the WCTCC wants to come it might be a good idea to have them email because if you're getting a whole group, that room can only accommodate so many people." Mr. Koluder, "If you plan on coming to one of those meetings, please e-mail back to Mary because we'll have to change the location because the room right now is not going to accommodate as many as we get here."
