APPROVAL OF MINUTES

TREASURER'S REPORT

Diane Figg reported all members should have received the reports. Ms. Figg continued reporting; the ending checking account balance as of December 31st was \$10,534.64. We spent a total of \$4,416.10 in 2016 with the biggest expense being the audit of the TCC which was \$1,800 and insurance was \$1,803. We have two bills that need to be approved for 2017; advertising for our meetings for \$167.70; and our website payable to SYF in the amount of \$269. The estimated budget for 2017 is also included in your packet. Ms. Figg also recommended no assessment for 2017.

3. **Statement of Financial Interests.** Scott Sistek reminded the WCTCC members the Statement of Financial Interests Forms required by the State Ethics Commission are due to Caprice Mills by May 1, 2017.
4. **Update Contact List.** Caprice Mills requested postage reimbursement to send the current contact list to all municipalities, boroughs and school districts for verification.
