## TREASURER'S REPORT

Diane Figg reported that the budget for 2014 was \$31,810 and only \$24,460.67 was spent. The checking account balance as of the last meeting was \$39,745.76. The bills posted totaled \$1,444.48 but an additional \$83.40 needs to be added to include the bill for advertising the change in meeting in the Tribune-Review for a bill total of \$1,527.88. Ms. Figg continued stating the budget is on target and no assessment would be necessary until 2016. Ronald Martz MOVED to approve the Treasurer's Report as presented, and Paul Fry SECONDED. No discussion. Motion carried.

## **SOLICITOR'S REPORT**

Solicitor Maiello reminded the committee that at the October Meeting an extension of the contract with Berkheimer through 2018 had been approved. Solicitor Maiello reviewed the highlights of the contract: commission was dropped from 1.45% to 1.42% retroactive to January 1, 2015; a price guaranty provision was included stating that if another similar Tax Collection District (TCD) is provided a lower rate than 1.42%, Berkheimer would match that rate; and at Berkheimer's request a reduction in the bond would be reviewed.

- 2. Selection of 2015 Operating Board. Scott Sistek reminded the WCTCC the Operating Board must have 10 members; five members representing School Districts and five members representing Municipalities and no more than two can come from the same School District boundaries.

Four members from the current Board representing School Districts have accepted reappointment for another one-year term: Joe Koluder, Derry School District; Mike Wrobleski, Yough School District: Dan Watson, Latrobe School District; and Diane Figg, Southmoreland School District. Jim Meyer, Greensburg Salem School District, has resigned, and Jennifer Callahan, Burrell School District, expressed an interest in filling the vacancy. A voice vote was taken from the members representing the School Districts in attendance this morning. **Unanimously all voted to approve the slate of candidates.**
