<u>PUBLIC COMMENT</u>-For the record there was no public comment presented at tonight's meeting.

### TREASURER'S REPORT

Diane Figg indicated there are two bills outstanding; the legal bill in the amount of \$367.50 and the Tribune-Review bill for advertising in the amount of \$162.63. Ms. Figg reported the only Political Subdivision still owing is North Belle Vernon Borough in the amount of \$141.28. At this time the balance in the checking account is \$63,253.75.

Diane Heming **MOVED** to approve the Treasurer's Report and pay the bills as presented, and Ronald Martz **SECONDED**. No discussion. **Motion carried**.

Ms. Figg continued reporting on the Budget stating the one item that would need to be paid every year is the auditing fee of approximately \$20,000. Legal costs for 2013 were \$2,600 with the possibility of receiving a reimbursement relating to the CENTAX claim. Additional operating costs built into the 2014 Budget include liability insurance; advertising; transcription services; and the website maintenance fees. Ms. Figg's projection for expenses for 2014 will be \$31,000 with the most cost related to the audit fee. No assessment should be necessary until the year 2016.

- 1. **2014 Budget.** Greg Primm **MOVED** to approve the 2014 Budget as presented, and Linda Iezzi **SECONDED.** No discussion. **Motion carried.**
- 2. Selection of 2014 Operating Board. Scott Sistek reminded the WCTCC the Operating Board must have five members representing School Districts and five members representing Municipalities and no more than two can come from the same School District boundaries. Three members from the current Board representing School Districts have resigned; John Wilson, Jude Abraham and Jon Perry. The current Municipal members and the two School Board members have expressed an interest to remain on the Board. The following representing the School Districts were nominated and/or already on the Board and wished to remain: Diane Figg, Southmoreland School District; Jim Meyer, Greensburg Salem School District; Dan Watson, Latrobe School District; Joe Koluder, Derry School District; and Mike Wrobleski, Yough School District.

A motion was made and seconded to approve the slate of candidates representing the School Districts. No further discussion. A vocal vote was taken. **Unanimously all voted to approve the slate of candidates.** 

The following six candidates representing the Municipalities expressed an interest in serving on the Operating Board and were nominated: Scott Sistek, Caprice Mills, Paul Fry, Diane Heming, Greg Primm and Doug Weimer.

At this time a public vote was conducted with each Municipality voting for five candidates.

Scott Sistek received 28.73% of the vote representing 100% of the vote; Caprice Mills, 28.73%; Paul Fry, 28.35%; Diane Heming, 28.27%; Greg Primm, 21.93%; and Doug Weimer, 7.71%. The current sitting Board received the highest votes.

Scott Sistek confirmed the 2014 Operating Board members as follows: Municipal Representatives are Scott Sistek, Caprice Mills, Paul Fry, Diane Heming and Greg Primm; and the School District Representatives are: Diane Figg, Jim Meyer, Dan Watson, Joe Koluder and Mike Wrobleski.

**3. Statement of Financial Interests.** Scott Sistek reminded the WCTCC members the Statement of Financial Interests Forms required by the State Ethics Commission are due to Caprice Mills by May 1, 2014.
